It is informed to all interested NGOs/Institutions that Ministry of Social Justice & Empowerment, Govt. of India has released a revised guidelines for the Implementation of Integrated programme *for Senior Citizens* on 01-04- 2018.

The Revised Guideline for the scheme is available in Govt. of India's **Web-Portal** "<http://www.socialjustice.nic.in>". The Govt. of India has invited proposals through the Govt. of Assam from interested NGOs /Institutions with adequate experiences in the sector. Accordingly proposals are invited from registered NGOs/Institutions with experiences in the fields of Integrated programme for Senior Citizen and with adequate financial capacity. Interested NGOs/Institutions may submit online applications through Web **Portal (e-Anudaan)** <http://www.ngograntsje.gov.in> as per revised guidelines to respective DSWOs (One hard copy shall have to be submitted to respective DSWOs) on or before 08/08/2018. The DSWO shall have to authenticate the activities of the organisation by making spot verification within 8th August, 2018 to 15th August, 2018. The proposals are to be placed by the DSWOs before the District Level Committee within 20th August,2018 for recommendation. Thereafter, The DSWOs shall have to forward the recommended proposals to the Directorate of Social Welfare, Assam, Guwahati on or before 25th August,2018 positively. Submission of the proposal directly at the Social Welfare Department, Assam, Dispur or Directorate of Social Welfare, Assam, Guwahati will not be entertained.

Projects are:-

1. Senior Citizen Homes/Senior Citizen Homes for Women including those under sansad Adarsh Gram Yojana for Districts of Majuli, Kokrajhar, Dhemaji, Tinsukia, Biswanath, Goalpara, Bongaigaon, Dhubri, Chirang, Baksa, Nalbari, South Salmara, Udalguri, Sivsagar, Charaidew, Dima Hasao, Barpeta and East Karbi Anglong.
2. Continuous care Homes and Homes for Senior Citizens afflicted with Alzheimer's disease/ Dementia for all Districts from Assam. (Note - Recognized Charitable Hospitals/Nursing Homes/Medical Institutions/Colleges are also eligible)
3. Maintenance Mobile Medicare Unit for Districts of Majuli, Kokrajhar, Baksa, Barpeta, Chirang, Dhemaji, Dima Hasao, Jorhat, kamrup, karbi Anglong, Karimganj, Nalbari, Sivsagar, Tinsukia and Udalguri. (Note - Recognized Charitable Hospitals/Nursing Homes/Medical Institutions/Colleges are also eligible)
4. Regional Resource and Training Centers (RRTC) for Districts of kamrup and kamrup(M).
5. Physiotherapy clinics for Senior Citizens. (Note - Recognized Charitable Hospitals/Nursing Homes/Medical Institutions/Colleges are also eligible)
