  - d. does not fulfill the qualification and experience prescribed in the Act and rules made there under and in such a case the Selection Committee, constituted under Rule 87 shall after due inquiry and on establishment of such fact, reject his application and recommend the name of the next person from the list of names prepared for filling the vacancies.
  - e. Person is engaged in Child Care Institution (CCI) Children Home / Adoption Agency / Open Shelter under JJ Act.

The Social Workers / Members (JJB / CWC) shall be paid **Rs.1,500**/- (Rupees Fifteen Hundred) only per sitting (minimum 6 hours) as travel, sitting & conveyance allowance as per ICPS guideline.

Applicants shall submit applications along with a self declaration certificate by **9**<sup>th</sup> **August 2021** during office hours. Copy of self declaration certificate attached with the advertisement.
